1. **Horace Mann's Disney Institute Sweepstakes** Promotion (the "Promotion") commences at 10:00 A.M. Central Time ("CST") on Wednesday, March 25, 2026, and ends at 10:00 A.M. CST on Wednesday, April 8, 2026 (the "Promotion Period"). All Promotion entries must be received by 10:00 A.M. CST on Wednesday, April 8, 2026. Entries submitted past the expiration of the Promotion Period will not be accepted.

2. *Sponsor.* The Promotion is sponsored by Horace Mann Service Corporation ("Sponsor" or "Horace Mann"). Entrants, Winning Schools, and Designated Educators are not obligated to make a purchase of any kind from any person or entity, renew any existing policy, become a customer of Sponsor, have multiple lines of insurance with Sponsor, request or obtain an insurance quote, or open new lines of insurance with Sponsor in order to either enter this Promotion, maintain eligibility in this Promotion, or to win a prize.

The random selection will be administered by a digital third-party software application to ensure impartial selection. Each Winning School will receive one (1) prize consisting of a fully paid opportunity for one (1) educator, as designated by the Winning School in its sole discretion, to attend the Disney Institute workshop, *A Heart for Service in Education: Delivering Service Excellence Through Purposeful Connection*, to be held on May 11, 2026, at a Disney location in Orlando, Florida.

The prize includes round-trip coach air transportation, resort lodging for two (2) nights (May 10–12, 2026), and meals as determined by Sponsor. The Designated Educator will travel to Orlando on May 10, 2026, and return on May 12, 2026.

Each Winning School must designate an eligible educator (each, a “Designated Educator”) within a time period specified by Sponsor, and such Designated Educator must meet all eligibility requirements set forth in these Official Rules and complete any required affidavits, releases, or other documentation. If a Winning School fails to designate an eligible educator within the required time period, or if the Designated Educator is unable or unwilling to participate, Sponsor reserves the right to select an alternate Winning School.

As part of the entry, Entrants must identify and nominate an eligible school or school district (the “Nominated School”) for consideration in the Promotion.
