#### Description:

The fund invests mainly in a diversified group of high-yielding, higher-risk corporate bonds—commonly known as “junk bonds”—with medium- and lower-range credit-quality ratings. The fund invests at least 80% of its assets in corporate bonds that are rated below Baa by Moody’s Investors Service, Inc., have an equivalent rating by any other independent bond-rating agency, or, if unrated, are determined to be of comparable quality by the fund’s advisor. The fund’s 80% policy may be changed only upon 60 days’ notice to investors. The fund may not invest more than 20% of its assets in any of the following, taken as a whole: bonds with credit ratings lower than B or the equivalent, convertible securities, and preferred stocks. This is an aggressive investment.
